The Hon'ble Supreme Court of India through Order dated 20.07.2018 as per the reference cited 1st above, has directed the Admission Supervisory Committee to conduct the Aptitude Test for admission to First Year B.Arch Course for the Academic Year 2018-19 for filling up the vacant seats in the state of Kerala.

Accordingly, the Architecture College Management Association (ACMA) has submitted a proposal & time schedule for conducting the Aptitude Test for Architecture, as per the reference cited 2nd above.

In the above circumstances, the ASC has decided to conduct the Aptitude Test in Architecture on 12.08.2018 at Ernakulam District only. The time schedule submitted by the ACMA is approved with certain modification. The time schedule is as shown below.
